### Industry

#### PROBLEM STATEMENT

Submit a solution that has been implemented or is implementable in an Indian city, demonstrating clear benefits to citizens or addressing a specific urban challenge.

#### ELIGIBILITY CRITERIA

Industries eligible for participation include firms registered under the Company Registration Act of 1956/2013 or MSME-registered startups and small-scale firms.

#### SUBMISSION GUIDELINES

- **Type of Submission:** A short presentation or video showcasing a good practice related to any of the 10 themes, emphasizing the journey from planning to implementation.
- **Judging Criteria:** Submissions will be evaluated based on impact, scalability, replicability, innovation, and the quality of the presentation.

#### TERMS & CONDITIONS

- For an implemented solution, the submission must be accompanied by a duly signed No Objection Certificate (NOC) from the relevant authorities of the city, state, or UT where the solution has been implemented. A template for the NOC is provided in the annexure.
- To qualify for Urban Learnathon 2.0, the submitted solution must have been successfully implemented within the last five years, ensuring its relevance and practical applicability.
- The submitted solution must clearly demonstrate alignment with one or more of the ten specified themes outlined in the submission guidelines. This alignment is essential for evaluating the relevance of the solution to the competition's objectives and for facilitating meaningful comparisons between submissions.
- Submissions should clearly articulate the solution's impact on the urban environment and its potential for replication or scaling in other contexts.
